“ON YOUR MARKS...!” STORIES OF JESUS FROM MARK’S GOSPEL, SUMMER HOLIDAY CLUB, 2024

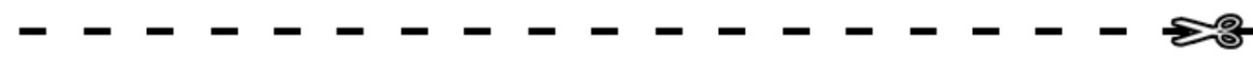
Holiday Club at Ferring Baptist Church will run from Tuesday, 6th to Friday, 9th August. The sessions will be from 10am – 12 noon on all four mornings and there will be a Grand Finale and buffet on the Friday beginning at 6pm to which families are invited. The whole club is free of charge, including the food on Friday evening at the Grand Finale, although we do ask you to book your places to that for catering purposes. All sessions are led by an experienced team including both Revd. Shirley from St. Andrews Church and myself, and every group leader will have obtained the necessary child safeguarding disclosure.

The theme to this year’s Holiday Club is based around being part of a team and will tie in with the Summer Olympic Games and daily activities include games, songs, quizzes and crafts. Games are outdoors whenever weather allows, and safe footwear (eg trainers rather than flip-flops) is essential every day. Games on Friday morning will involve a certain amount of water, but if you do not want your child to get wet you can indicate this on the form below. We also include Holiday Club photographs in the publicity on our church’s website, and it is possible that your child’s face might appear in one of these. Again, if you do not wish this to happen you can refuse permission on the form below.

Children aged 5-11 yrs are welcome and, while not essential, it helps a lot if you register your child(ren) before the club begins, in order for us to assess the numbers likely to attend. You can do this by filling in the form below and posting it to us at the church, or putting it through the church letter-box when passing by. Alternatively you are welcome to register your child(ren) on the first morning that they join us. (Further forms are available on our website on the holiday club page). All children must have the consent of a parent (or adult with legal parental responsibility). It is essential that all of the details required on the form are filled in, using a separate form for each child (further forms are available from the church website).

Privacy Notice to Parents/Carers

When you register your child to attend Holiday Club we ask you to provide us with personal information (as requested on the registration form) about yourselves and your child. This is so that we may always act in your child's best interests, and so that we may legitimately contact you when necessary, either about your child or about matters related to the club and its activities.

We also sometimes use such information after Holiday Club has ended in order to tell you about other events and activities that we believe may be of interest to you or your child, but you may at any time instruct us not to do this. Your personal details, and those of your child are kept securely, and are normally retained for one year. An exception to this time limit applies to children aged nine and above, whose details we retain until they are twelve or thirteen years old so that, where appropriate, they may be invited (with your consent at the time) to become junior members of the Holiday Club team.

At any time you may instruct us to delete and destroy personal information before the usual period has elapsed. Where details change you may also ask us to update the information we hold. If at any time you have concerns about the way your (or your child's) details are being processed you are welcome to contact me on (01903) 249996.
